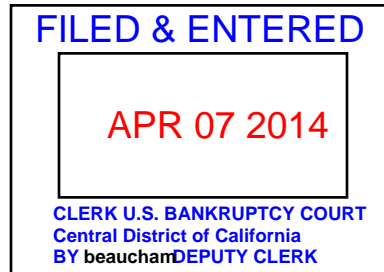

JUDGMENT IN ADVERSARY  
PROCEEDINGS

1 It is hereby **ORDERED, ADJUDGED AND DECREED** that:

2 1. Plaintiffs, the J.T. Thorpe Settlement Trust and Thorpe Insulation Company  
3 Asbestos Trust (collectively "Plaintiffs"), shall have judgment against Defendants Michael J.  
4 Mandelbrot and the Mandelbrot Law Firm (collectively "Defendants") in these adversary

6 as well as the Court's Order Following Trial;

7 2. Plaintiffs' claim for equitable relief is dismissed as to all Defendants without
